#### 1. CHAIRMAN'S ANNOUNCEMENTS

Prior to the election of the Chairman of the Council, Councillor R J S Long referred to the time he had been Chairman and the two most memorable highlights of this time were the visit by Her Majesty the Queen in October 2011 and the welcome he had received from fellow Members of the Council in February 2012 following his return from intensive care. He thanked Officers, in particular Stuart Jennings, Alia Hamdan, Jill Punch, Val Downes, the Chief Executive and Leader of the Council for their support during his time as Chairman of the Council. He then made two presentations, to Tara Bird for her help and assistance to him, then his wife for accompanying him at all functions and the support she had given him throughout his term in office. Councillor Long also presented the Members of the Council with an English translation of the Magna Carta from 1215.

Councillor Long referred to the recent tragic death of Councillor R H G Porter and paid tribute to him. All present at the meeting then stood in silent tribute to the memory of Russell Porter.

The Council received and noted the report by Councillor Bryan Harker, Chairman of the Essex Outward Bound Association, detailing the annual activity and fund raising undertaken by the Essex Outward Bound Association during the year 2011 / 12.

Councillor Harker advised that paragraph three of his report should refer to four "last minute cancellations". This was noted.

### 31. APPOINTMENT OF MEMBERS TO SERVE ON WORKING GROUPS OF THE COUNCIL

#### 32. MALDON DISTRICT LOCALITY BOARD

The Council received and noted the report of the Chief Executive updating Members on progress of the formation of a Maldon District Locality Board.

Councillor R G Boyce declared a personal and non-prejudicial interest in this item of business as a Member of Essex County Council.

Councillor Mrs P A Channer declared a personal and non-prejudicial interest in this item and any other relevant items of business as a Member of Essex County Council.

Members were reminded how the Council in February 2012 had approved the formation of a Locality Board for one year's trial. Since then Essex County Council had designated Councillor Derrick Louis as the Cabinet Member to sit on the Maldon District Locality Board.

A meeting had recently taken place with Councillor Louis to discuss the arrangements for the board. Four key items for the agenda of the first meeting had been identified and were outlined in the report. The first meeting of this Board would take place towards the end of May 2012 with a rotating Chairmanship between the Essex County Council Cabinet Member and the Leader of the Maldon District Council.

**RESOLVED** that the report be noted.

#### 33. URGENT BUSINESS

The Chairman announced that in accordance with Section 100B(4) of the Local Government Act 1972 he had agreed to allow the Chief Executive to seek approval from the Council on the following matter.

#### 34. COUNCIL MEETING DATE - JULY

The Council considered the report of the Chief Executive seeking the Council's agreement to change the date of its next meeting. This report was urgent due to the need to determine whether this change was to be made.

It was reported that the Leader of the Council together with some other Members would be unavailable to attend the next scheduled meeting of the Council on 12 July 2012. The Leader of the Council was required to make a speech at the July meeting of the Council during which he would present the governing administration's programme for the coming year. In light of this it was requested that the July meeting of the Council be brought forward one week to 5 July 2012. This was agreed.

**RESOLVED** that the next meeting of the Council be changed to 5 July 2012.

At this point in the meeting Councillor B S Beale raised a point of order, advising that when a new Chairman of the Council was elected they normally made a declaration that they would not be part of any political party. He asked the Chairman if this had been forgotten or whether it was his intention to be part of a political group. In response the Chairman apologised for the oversight and affirmed that he would not be a Member of the Conservative Group during his year of Office, but would remain a Conservative for the purposes of political balance. Therefore he would present, as Chairman of the Council, a neutral stance at all meetings of the Council.

Councillor R J S Long made reference to Councillor P G L Elliott who was standing down as Chairman of the Finance and Corporate Services Committee and how he and the Finance staff should be commended for the work they had done.

#### 35. EXCLUSION OF THE PUBLIC AND PRESS

**RESOLVED** that under Section 100A(4) of the Local Government Act 1972, the public be excluded from the meeting for the following item of business on the grounds that it involves the likely disclosure of exempt information as defined in Paragraphs 1 and 2 of Part 1 of Schedule 12A to the Act, and that this satisfies the public interest test.

### 36. MINUTES OF THE APPOINTMENTS COMMITTEE - 9 MAY 2012

Further to the earlier decision to discuss these Minutes and the recommendation contained within them in closed session, the Chairman opened up this item of business for discussion by the Council.

#### Minute 917 – Post of Chief Executive and Head of Paid Service

A number of concerns were raised regarding the reporting of this matter and the information received by Members. A debate ensued.

Following further discussion, Councillor R Pratt proposed that the Council postponed making a decision on this matter to the next meeting of the Council. He felt that in light of the concerns raised by other Members that to agree the recommendation at this time would be wrong. This proposal was duly seconded by Councillor S J Savage.

Councillor F A Delderfield then spoke against Councillor Pratt's proposition, advising how the Appointments Committee had met three times during which legal advice was given and further advice from the Local Government Association sought. He reported that the Committee had carefully considered all advice received. Councillor Delderfield then proposed that the recommendation of the Appointments Committee, as outlined in the Minutes, be moved. This proposal was duly seconded by Councillor A T Cain.

The Chairman put Councillor Pratt's proposition to the Council and upon a vote being taken this was declared lost. He then put Councillor Delderfield's and upon a vote being taken this was agreed.

#### RESOLVED

- (i) that the Chief Executive's contract is recognised as permanent in accordance with legal advice and the de facto position and that Ms Marshall's permanent contract be confirmed to her in writing as soon as possible;
- (ii) that the permanent contract is prepared in accordance with the standard contract offered to all Maldon District Council employees and updated to reflect the Joint Negotiating Committee Conditions of Service for Chief Executives, with no change to the Terms as agreed by the Appointments Committee in June 2010;

(iii) that a review of the Human Resources' process for fixed term contracts be undertaken and any necessary steps to ensure a robust process in the future were put in place.

#### **RESOLVED**

(iv) that the Minutes of the Appointments Committee on 9 May 2012 be adopted.
