7.4 Representations received from Interested Parties

7.4.1 A letter of representation has been received since the publication of the Agenda questioning why the item is being presented to the North Western Area Planning Committee, why the number of 3000 flights is only mentioned in the updated report and setting out that they maintain their objections as public speaking is not an opportunity at the meeting.

A response to the objector was provided clarifying that the item is being returned in order for Officers to ensure that the resolution is entirely in accordance with the intentions and the resolution of Councillors and to highlight the necessity to amend the Unilateral Undertaking to the decision makers. Additional Information

An email correspondence dated 26 October 2018 was received informing the case officer that an email dated on 25 October 2018 has been circulated to Members at the North Western Area Planning Committee regarding the development proposal. In that email correspondence, it states that the Applicant does not consider that the development would have an impact on the countryside as the application site is screened by existing vegetation and is next to an established employment area. The design and location of the building have also been considered to minimise impact to the area.

The email goes on to say that other sites / buildings have been considered but are 'too large, unaffordable or too remote from the A12 / A414'. The development proposal would therefore accord with policies in the LDP as it meets the need of local businesses and attracts investment to the District.
