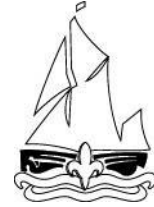

A vehicular link to the western boundary was proposed as part of the outline planning permission but, as the applicant has suggested, this matter could be addressed through the imposition of a condition. An additional condition is recommended below.</p>

8. PROPOSED ADDITIONAL CONDITION

- 4 The road network hereby approved shall not be beneficially used unless and until a vehicular link to the western boundary of the site has been provided in accordance with details which shall have been submitted to and gained the prior written approval of the local planning authority.

REASON

In order to ensure that vehicular access to property to the west of the application site is maintained, in the interests of highway safety and convenience, in accord with Policy T2 of the Maldon District Approved Local Development Plan, and the NPPF.
