665. APPLICATION FOR A GRANT OF A NEW HACKNEY CARRIAGE / PRIVATE HIRE DUAL DRIVER'S LICENCE - DECISION

The Chairman advised that the Sub-Committee had considered the report of the Licensing Officer, the applicants' personal circumstances and submissions and had regard to the Licensing Act and the Council's Licensing Criminal Convictions Policy. Referring to the Council's Policy she informed those present that a licence would not usually be granted unless un exceptional circumstances. The Sub-Committee felt that the applicant had not demonstrated any exceptional circumstances which would justify departing from policy. It was considered that the applicant was not a fit a proper person to hold a Hackney Carriage / Private Hire Dual Licence.

RESOLVED that *the applicant* be **REFUSED** a Hackney Carriage Private Hire Dual Licence.
