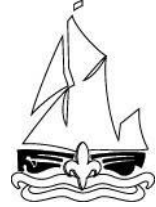

1. CHAIRMAN'S NOTICES

The Chairman drew attention to the list of notices published on the back of the agenda.

2. APOLOGIES FOR ABSENCE

There were none.

3. MINUTES OF THE LAST MEETING

RESOLVED

- (i) that the Minutes of the meeting of the Committee held on 13 March 2019 be received.

Minute No. 964 – Maldon District Community Partnership Update

Councillor M S Heard requested that it be clarified whether the 185 Stop Checks conducted related to the Maldon or Chelmsford area.

Councillor M S Heard requested that the minute be amended to include the additional word (highlighted in red) as follows:

*“Police accessibility – There was a brief discussion regarding the loss of village police offices and Members were advised that the Government had changes the policing model and it was now necessary to identify innovative ways **to** engage with residents...”*

RESOLVED

- (ii) that subject to the above amendment the Minutes of the meeting of the Committee held on 13 March 2019 be confirmed.

4. DISCLOSURE OF INTEREST

Councillor M S Heard declared that he no longer had a non-pecuniary interest in all agenda items as he had retired from the police service.

5. PUBLIC PARTICIPATION

In accordance with the Council's Public Question Time and Participation at Council and Committee Meetings Scheme, Councillor Chrisy Morris addressed the Committee as a member of the public.

Mr Morris raised concerns and requested that Inspector Barry Booth note his comments for further investigation.

6. ESSEX COMMUNITY REHABILITATION COMPANY

The Committee received a presentation from Ms Kirsty Gibbons, Manager of Service Delivery for Essex Community Rehabilitation Company (ECRC), which informed the Committee of the work conducted on the rehabilitation of service users through community payback following Community Court Referrals.

As part of the presentation, and in response to questions from Members, the following information was provided:

- The ECRC manage low to medium risk cases. High risk cases were managed through the Probation Service;
- At time of writing the report:
 - There were 47 service users in Maldon, 6 in Southminster, 3 in Heybridge and 6 in Burnham-on-Crouch;
 - 13.04% female, 86.96% male;
 - The majority of service users were between 20-29 years of age;
- A large proportion of service users undertake unpaid work, with the inclusion of a punitive element alongside rehabilitation;
- As part of Rehabilitation Activities Requirements (RAR) probation officers work alongside other agencies to address other requirements service users may have as part of their rehabilitation, i.e. addressing drug use. This would ensure that service users were getting full value from rehabilitation;
- Unpaid work supports many areas of the community. A large number of non-profit organisations have been supported, some local authority work undertaken including local churches and schools. This unpaid work provided a visible demonstration of justice within the community. Within Maldon, service users have undertaken unpaid work at the *Museum of Power* and *Heybridge Cemetery*;
- A Community Court Referral can sentence Community Payback for up to 300 hours. This was expected to be a minimum of seven hours per week, where the

service user was employed, up to twenty-eight hours per week where the service user was unemployed;

- Service user surveys show that 99.8% of offenders were less likely to re-offend having completed Community Payback;
- As part of the service, Community Integration Officers work closely with the Jobcentre Plus (JCP), and refer and support the acquisition of various qualifications, such as the Construction Skills Certification Scheme (CSCS), by service users;
- Once employment is achieved a review gets carried out, however, following the end of the court order, no further information on service users was received.

Ms Gibbons advised the Committee that the team would welcome suggestions and projects as they are always looking for ways to best support communities through payback. Members were also advised that, if they were inclined to do so, site visits would be welcome.

The Chairman, on behalf of the Committee, thanked Ms Gibbons for an interesting and informative presentation.

7. MALDON DISTRICT COUNCIL COMMUNITY SAFETY PARTNERSHIP UPDATE

The Committee received the report of the Head of Paid Service, presented by Mr Spencer Clarke, the Community Safety Manager at Maldon District Council. The report provided Members with an update on the progress of activities undertaken by the Maldon Community Safety Partnership (CSP) since the previous meeting of this committee (13 March 2019) and to inform on the strategic priorities for 2019/20.

The report provided a detailed update on the following matters:

- Statutory Duties – the CSP was required to produce the Strategic Assessment of Crime, a draft was currently being reviewed with publication expected for December 2019-January 2020. It was noted that as part of the Crime Risk Matrix, which looks at over 30 different types of crime within Maldon district the majority of cases, as a result of public perception, related to road use, i.e. speeding, dangerous and irresponsible driving.
- Priorities for the partnership were reported as tackling violent crime; driving down anti-social behaviour; identifying and supporting vulnerable people; rural crime and promoting road safety and challenging irresponsible driving.

Members' attention was drawn to the Essex Police force crime performance data for Maldon and the Essex comparison which was attached at appendix 1 and 2 of the report. It was noted that the number of offences per 1,000 population was one of the lowest out of the Essex districts.

- Eastern Region Counter Terrorism Local Profile – Main issue for Essex was a trend in the radicalisation of youths through social media and the internet. The CSP continue to work with Community Partners with representation from Jewish Community, Black African Communities and universities to monitor all

types of hate crime.

- Police, Fire and Crime Commissioner (PFCC) Update – The PFCC encouraged concerns to be forwarded to determine concerns and priorities in the local area. It was noted that the increase in the Council Tax Precept for 2018/19 had funded the employment of an additional twelve officers for the region, of which six were deployed to Maldon. The next increase will be contributing towards the town centre, with the anticipated acquisition of four more officers, to focus specifically on rural crime.

Additional funding was received from the Home Office which totals £2.2 million and goes towards youth crime prevention and a Violence Reduction Unit.

- Community Safety Partnership Hub – Maldon staff are now co-located at the Chelmsford hub, as of 26 March 2019. The co-location had seen an improvement in tackling crime, safeguarding and effective policing.
- Operation Overwatch – Operation Overwatch has been deployed five times and identified hot spots within the region. Within Maldon, one of these was Promenade Park where effective policing had identified and neutralised various offences and low-level nuisances. The Parish Clerk Forum had provided good intelligence on where these issues had occurred around the area and received positive feedback on the work carried out.
- Work with the Crucial Crew is currently being reviewed and restructured as it was considered more effective that they approach primary schools in the Spring prior to students moving on to Year 7.
- Positive prevention work was being carried out with youths through Colchester United Football Club working in schools on issues like knife crime, gang crime, embedding positive values.
- Progress on Action Plans – a brief update was given on some of the projects which had been progressed throughout the year:
 - Neighbourhood Watch – effective communication tools included the use of social media and a newsletter to communities.
 - Community Payback – since April 2019, over 800 hours of community payback had been carried out across the district, this included work in cemeteries, churchyards, and green spaces.
 - TruCam – Maldon District Council was the first district within the country to introduce additional enforcement through TruCam.
 - Domestic Abuse Training – Members were informed that training would be carried out in the Council Chamber on 26 November 2019 which they were welcome to attend. This would be delivered by Safer Places.

At this point Councillor M S Heard asked that his disappointment at the non-attendance of the Police Fire and Crime Commissioner (PFCC) be recorded in the minutes. He then went through the crime figures in all areas noting the increases. He acknowledged that some good work was being done but crime was still rising albeit reported as falling. He said he had not seen evidence of local, visible and effective policing reversing the trend in serious violence. He requested that the PFCC attend a future meeting to explain the crime statistics. The Chairman reminded the Committee that the Committee can extend an invitation but cannot demand that the PFCC attend.

Councillor Nunn endorsed the earlier comments and said that the Highstreet in Maldon was the worst it had ever been for drug use, drunkenness and violence and said it was exacerbated by low visibility of police.

The Community Safety Manager advised that the PFCC held public meetings across the district, one in Maldon in January, Chelmsford two weeks ago with twenty five in attendance. He reminded Members that the Scrutiny at this meeting was through the work of statutory partners and the PFCC was not a member of Maldon Community Safety Partnership (CSP) the group that reported to Overview & Scrutiny (Crime & Disorder) Committee.

In response to a question on prevent referrals the Public protection Manager advised that there were currently no preventative referrals within Maldon, it was noted that this was usually 30 per annum with the majority of cases being within education. It was acknowledged that the main concern was grooming through internet and social media fora.

Inspector Barry Booth then addressed a question from Councillor Siddall regarding drugs and other problems in rural communities. He reported that one of the first things he put in place was a third team. There were six additional officers, split across three teams, who were dedicated to rural policing. Acknowledging Members concerns, he said he hoped to see more of a police presence in rural areas, the ideal would be to have a discrete rural team but resources were dependant on government funding. He said if the allocated Maldon Officers were not visible enough he would take that back and ensure that officers were making themselves known in the community.

Councillor W Stamp, with permission of the Chairman and in accordance with Procedure Rule 20, asked the Community Safety Manager where the money generated from the TruCam fines was allocated and was advised that the money went to the Police Team. Councillor Stamp went on to thank Essex Police for boosting the police presence within Burnham-on-Crouch and the increased engagement within the community. It was further noted that the initiatives introduced by the Chief Inspector, Gerry Parker had been very effective and gave the force the freedom to do what they need to do.

The issue of adequate police space at Maldon was raised and the Director of Service Delivery confirmed that the Council was awaiting confirmation as to whether Essex Police wanted to lease additional space (both internal and parking facilities) at the Princes Road offices. Inspector Barry Booth said he would discuss this with his facilities team and report back to the Director of Service Delivery.

The Director of Service Delivery reassured Members that all partners were making a contribution to tackling crime in different ways and that the Council, supporting the

police through the Community Protection Team and the use of TruCam, was really proactive and at the forefront of this work.

The Chairman then put the recommendation to the Committee and it was agreed.

RESOLVED that Members reviewed and commented on the new current progress and the success of the initiatives undertaken by the Maldon Community Safety Partnership (CSP) to date.

8. ESSEX POLICE REPORT

Inspector Booth presented his report to the Committee highlighting the following initiatives introduced in the last year:-

Project Enlightenment – re-invigorating officers into schools, this commenced end of December early January with the Plume, William De Ferrers, Ormiston Rivers Academy, Ramsden Hall and Heybridge. It was noted that it was not just middle and high schools that required intervention but also Primary Schools.

Engagement Strategy – the PCSOs have taken the lead on this and are responsible for supporting all local initiatives:- fairs; coffee mornings with police officers; support in schools; regattas. They co-ordinate all arrangements for the aforementioned events.

Tasking and Co-ordination - attending Safety Advisory Group meetings, Community meetings, MACE meetings etc. All feedback is taken away and acted upon as appropriate.

Operation Overwatch - work ongoing on sexploitation, drugs and gangs. Employing anti-social behaviour legislation such as Community Protection Notices ((CPNs) has been very effective, led by the Town Teams. There has been over seventy hours of police footwork, over forty searches, resulting in key arrests, community resolutions and dismantling organised crime groups.

CPT (Community Policing Team) – the team take control of briefings, all community information is incorporated into briefings that drive the activity of the police, very successful strategy.

Gypsy Traveller Rural Engagement Team – working with them on organised crime groups, breaking up burglary rings that prey on the elderly posing as police.

Neighbourhood Watch – reinvigorating the neighbourhood watch. A success story in the Chelmsford area at the moment . Rolling out the active alert mobile telephone system which is now being used by three communities. The information provided through this system fills in the blanks for the police around local crime. This is working very well around drug dealing, suspicious persons, lifetime intelligence which has led to a number of significant arrests. Noted that should other communities wish to sign up to the active alert number they should contact Sergeant Matt Dalby.

Stop and Search - ninety plus stop searched since the beginning of January in Maldon alone. This is something we should be doing more of given the current climate.

In response to questions Inspector Booth responded as follows:-

- that Police attendance at Parish/Town Council meetings can be co-ordinated on email via an intelligence sharing document. This would generate an action on the central system and a Police Officer would be assigned to attend as required. In the case of Maldon Town Council, he signposted Members to the Town Sargeant Graham Thomas, to discuss the way forward. He added that as long as they had appropriate notice it should always be possible to send a police representative;
- that if necessary a separate active mobile alert phone could be set up for the farming community;
- that managing rural crime was a challenge given that the overall number of rural officers was only eight, there was a lot of area to cover and rural crime was on the increase. Police needed to know what the policing requirements were in these areas in order to prioritise resources;
- that noting the report of targeted burglaries of safes in the area he would liaise with the organised crime team and report back. He said that these types of crimes were not normally restricted to a given area;
- that following a report around youth anti-social behaviour and bullying in the Dengie he would step up engagement in Schools to drive down this type of crime;
- that he would continue to police robustly and make every effort to generate more resources to increase the number of police on the street. In the meantime, he reiterated that local information in line with what had been reported at the meeting was what the police needed in order to better allocate resources.

In response to a query regarding police station signage from Councillor Dewick the Director of Service Delivery said he would liaise with the Local Highways Panel and report back. Councillor W Stamp, referring to a recent meeting with the Assistant Crime Commissioner, Jane Gardiner, where it was agreed to look into pool cars being made available at Maldon as opposed to Chelmsford alone, be followed up. The Chairman said that he was meeting imminently with the PFCC and would take the matter up with him.

The Chairman then thanked Inspector Barry Booth for his excellent presentation.

There being no further items of business the chairman closed the meeting at 21:18pm

MALDON DISTRICT COMMUNITY SAFETY PARTNERSHIP UPDATE

1. PURPOSE OF THE REPORT

- 1.1 Members are asked to note the progress of activities undertaken by the Maldon Community Safety Partnership (CSP) since the last meeting held on 14 November 2019 and be aware of the proposed strategic priorities for 2020 / 21. The scheduled meeting on 19 March 2020 was cancelled due to Covid-19.

2. RECOMMENDATION

That Members review and comment on the current progress of the initiatives undertaken by the partnership to date and note the strategic priorities for 2020 / 21 and note the completed recommendations of the internal audit of the Community Safety Partnership.

3. SUMMARY OF KEY ISSUES

3.1 Statutory Duties

- 3.1.1 The strategic assessment was approved at the meeting of the Responsible Authorities Group on 6 February 2020 and the priorities for 2020 / 21 were endorsed. The priorities, listed below, reflect priorities already identified in the current Police and Crime Plan, the Essex Police Crime Prevention Strategy and the current Essex Police Strategic Assessment (control strategy). These priorities were highlighted on the Maldon District Council website. It should be noted that reducing reoffending remains a statutory function for all community safety partnerships and is embedded in the priorities listed below.

- Tackling crime and reducing reoffending (with an emphasis on violent crime, gangs and drug trafficking);
- Driving down anti-social behaviour in public places (with an emphasis on youth nuisance and improving partnership visibility);
- Identifying and supporting vulnerable people (with an emphasis on domestic abuse, social isolation, suicide prevention, mental health and hate crime);
- Increase confidence in identifying and reducing rural crime;
- Promoting road safety and challenging irresponsible driving.

- 3.1.2 These priorities will contribute to the Council's Corporate Goal of "Helping communities to be safe, active and healthy" and are highlighted as activities in the community safety action plan for 2020 / 21. Each activity has a clear timescale with a RAG (Red, Amber, Green) rating, proposed financial spend and milestone to enable performance monitoring of each project associated to the activity. This was a recommendation of the recent internal audit. Activities are reported quarterly to the Responsible Authorities Group, with a finance report and monthly through the community safety partnership hub tasking meetings. Meetings of the strategic group and the hub are diarised until March 2021.
- 3.1.3 The current Essex Police Maldon performance figures for the rolling year to 30 September 2020 (compared to the same period last year) showed a decrease in all crime by **2.1%** (77 less offences) and an increase in anti-social behaviour by **15.7%** (133 more incidents). It should be noted that there has been a decrease in all crime in Essex by 5.5% with an increase in anti-social behaviour by 12%. A summary of the crime profile for Maldon will be presented at the meeting by Chief Inspector Steve Scott-Haynes from the Chelmsford and Maldon Community Policing Team. A copy of the Essex Police force performance summary for the county is attached as **APPENDIX 1**. Some more local context of the issues surrounding these crime increases will be given at the meeting. The impact of Covid-19 has had a positive impact in terms of reported crime. However, there has been an increase in Anti-Social Behaviour (ASB) reports to the police and local authority during and post lockdown which is a combination of nuisance behaviour, noise, fly tipping, neighbour disputes and reports of Covid-19 breaches around social distancing. The District Council has received numerous service requests for ASB and fly tipping since 1 April 2020 to the present day. The police analyst has been monitoring these figures for the partnership since March 2020. Another area of increase during lockdown has been for domestic abuse support and the Essex Compass has seen an increase for services during the last six months.
- 3.1.4 The Essex Prevent Action Plan has been completed and is monitored on a quarterly basis at the Prevent Multi-Agency Group. The Maldon CSP Prevent action plan has been refreshed to accommodate these changes. Officers continue to work with the Prevent Team and local Counter Terrorism Security Advisors (CTSA) to ensure that local risks are addressed. Officers continue to engage with communities through the Independent Advisory Group which has been meeting monthly on Zoom during the Covid-19 crisis. The last meeting being held on 14 September 2020. This acts as a good forum to discuss community tensions, hate crime and policing interventions such as stop and search, and gives a voice to underrepresented communities. The Community Safety Manager has been attending the Excess Death and Bereavements meetings throughout the crisis and is now a member of the county Faith and Communities Tactical Coordination Group.
- 3.1.5 The partnership has a duty in relation to Modern Day Slavery and Human Trafficking under the Modern Slavery Act 2005 and as highlighted in the previous report there has been several training sessions delivered and links made with the Modern Slavery and Human Trafficking Unit at Essex Police. A virtual workshop for sixty members of partner agencies in Maldon has been arranged for 14 October 2020. My Mind is Free is being delivered by the Rah Rah Theatre Company with funding supplied by the Police, Fire and Crime Commissioner. The Local Government Association has

recently published a useful document on this subject:

3.2 Police, Fire and Crime Commissioner Update

- 3.2.1 The partnership continues to support the priorities identified in the Police and Crime Plan which has been extended for a further year:

- 3.2.2 Works continue with several multi-agency groups that support this work locally and across Essex. The Office of the Police Fire and Crime Commissioner (OPFCC) has confirmed that core funding for Maldon in 2020 / 21 will be **£12,527**. The Community Safety Development Fund (CSDF) will continue throughout 2020 / 21 for partnerships, charities and community groups to access funds which support the priorities of the Police and Crime Plan. However, funding for the first round of the CSDF Officers has been earmarked for charities who deliver on the community safety agenda who are being affected by the Covid-19 crisis. Last year's funding assisted financial support for several local initiatives. Funding has also been awarded to pan Essex projects such as Neighbourhood Watch, CrimeStoppers, J9, Stop Hate UK and the Modern Slavery Helpline. The PFCC has also recently allocated more than £700,000 to organisations in Essex helping to support victims and survivors of domestic abuse and sexual violence: <https://www.essex.pfcc.police.uk/news/pfcc-gives-more-than-700000-to-organisations-helping-to-support-victims-and-survivors-of-domestic-abuse-and-sexual-violence/>.
- 3.2.3 The Police, Fire and Crime Panel (PFCP) approved a further increase in the council tax precept for 2020/21 which will see recruitment of another 151 extra officers in 2020 / 21, an increase of 519 officers in the last three years. The Maldon representative for the PFCP is Councillor Michael Helm. - 3.2.4 Last year's increase in policing numbers saw the introduction of Town Centre Teams for Maldon, Chelmsford and South Woodham Ferrers and the Rural Engagement Team (RET) has also doubled in size which supports the priority of tackling rural crime and is now working very closely with the Council's community engagement officers. As previously reported, last year, the OPFCC made a bid on behalf of Essex to the Home Office early intervention youth fund which was successful and £664,000 has been allocated to Essex to address youth violence. Essex County Council has also contributed £500,000 to this budget for 2019 / 20 and a further £1,160,000 was awarded in September 2019 following a successful bid for the Violence and Vulnerability Unit (VUU). This has seen a central Violence and Vulnerability unit set up in the community safety partnership hub with a budget of approximately £2.2 million for Essex. The Community Safety Manager attends the Violence and Vulnerability Operations Board which reports into a Strategic Board. Officers are involved in the various workstreams from this strategic group: Few Causing Most Harm and Voice of Communities. It should be noted that in addition to funding above the VRU has been successful in being awarded a further £1.1 million for 2020 / 21 through a bidding process and the OPFCC will be topping up this fund by £200,000

and ECC by £500,000 for 2020 / 21. For further information on the VVU they can now be followed on Twitter @EssexVVU.

3.3 **Community Safety Partnership Hub and Progress Update**

- 3.3.1 The Community Safety Partnership Hub for Chelmsford and Maldon meets monthly and has a tasking process which links to the priorities of the Community Safety Partnership (CSP). Tasking has migrated to Microsoft Teams during the Covid-19 crisis with the most recent meeting being on 15 September 2020. There is an individual action plan for Maldon CSP plus a tasking update which is monitored to ensure that partner actions are completed and performance managed. A copy of the current Maldon CSP action plan is attached as **APPENDIX 2**. Subgroups of the partnership continue to meet on a regular basis and work streams for each individual group are effectively impacting on various areas of community safety. Regular attendees at tasking include council officers and CCTV staff, community policing team, Youth Offending Services, Essex Community Rehabilitation Company, Family Solutions, Peabody, Phoenix Futures, Children's Health & Wellbeing Service, The Children's Society, Neighbourhood Watch, Open Road and Social Care with other partners supporting the process when necessary (analytical support, serious organised crime, intelligence etc.). The community safety hub is occupied by CSP officers, the Community Policing Team, the Town Centre Unit and the Essex Violence and Vulnerability Unit (VVU). This has already improved joint working within the respective teams which will provide a much better service for the public in terms of performance, visibility and reassurance. This facility was highlighted as good practice in a recent "Investors in the People" assessment for Chelmsford City Council and during an audit of hubs for the PFCC.
- 3.3.2 Officers attend the MACE 1 and MACE 2 (Missing and Child Exploitation) meetings on Microsoft Teams to ensure that the needs of vulnerable children for the district are addressed and that processes are in place to tackle the criminal and sexual exploitation of young people. Officers also attend Mid-Essex Stay Safe, Mid-Essex Children's Partnership Board (MECPB), Chelmsford & Maldon Behaviour and Attendance Partnership (BAP), Maldon Youth Strategy Group and the County Safeguarding Leads meeting. Members should be aware that the MACE and BAP groups were both awarded funding by the VVU to support young people who are on the cusp of exclusion or deemed high risk in terms of vulnerability. The bi-monthly ASB forum held with local schools and other partners addresses youth issues and act as a point of early intervention before behaviour escalates. This forum has paused during the Covid-19 crisis but will commence again in the new academic year and now links better with the Behaviour and Attendance Partnership. Operation Enlightenment continues to prove successful and every secondary school in Maldon, and William de Ferrers in Chelmsford (Maldon catchment) is allocated with a dedicated officer who is a point of contact for issues, poor behaviour and an early intervention opportunity. Officers continue to support registered social landlords in tackling anti-social behaviours cases which in time should upskill partners to enable them to tackle anti-social behaviour more effectively and improve data sharing and intelligence. More complex neighbour disputes are dealt with on a case by case basis. Officers also meet with the community mental health teams on a bi-monthly basis to discuss complex cases and support arrangements for vulnerable persons, the most recent meeting being held on 7 August 2020. The partnership has supported Neighbourhood Watch

(NHW) throughout the Covid-19 crisis and has migrated members to Microsoft Teams which enabled them to continue ongoing dialogue.

- 3.3.3 The community safety team has been busy supporting agencies during the current crisis and has been focussing on delivering general safeguarding and enhanced training on virtual platforms. A suicide awareness flow chart has also been devised to provide basic training on how to respond to threats. Meetings have been held to consider communications and the partnership will be producing a bi-annual newsletter for the community and increasing its social media presence under the Safer Maldon banner. A new police officer, PC Chris Major, is now working in the hub and his role is a new post: Community Safety Engagement Officer which will be dedicated to improving engagement with our communities and will involve engagement on virtual platforms such as Facebook live events. Officers also supported by Essex County Fire and Rescue Services (ECFRS) and other partners deliver a Safe, Well and Secure day of action on 2 and 3 September 2020 in Burnham-on-Crouch. This included the delivery of door step organisation referral sheets and providing free smoke alarms to those residents who do not have them (home.safety@essex-fire.gov.uk). Over 800 homes were visited on the two days with 40 referrals being made for a variety of services. Officers from the community safety and community engagement teams will also be supporting a week of action in October to tackle metal theft and illegal waste carriers in partnership with the Essex Police Rural Engagement Team and HMRC. The High Sheriff of Essex attended the first day of action on 12 October 2020. The team has also been supporting Hate Crime Awareness Week by providing daily social media posts for the week (12 – 16 October 2020).
- 3.3.4 The capital project funded by Maldon District Council to replace the CCTV system for Maldon is now complete. A contract for capital works was awarded to Link CCTV Systems and commenced on 1 April 2020. This has seen virtually every camera in Maldon migrate to digital high definition units with full connectivity over a secure video management system and extended areas of coverage. This has seen several corporate sites upgraded including the High Street, Promenade Park, Hythe Quay, Riverside Park in Burnham-on-Crouch and two community centres at Brickhouse Farm and West Maldon. These images have been remotely monitored at the Chelmsford CCTV Control Centre since 1 July 2020 by skilled CCTV operators who are licensed by the Security Industry Authority (SIA) and accredited officers under the Essex Police CSAS scheme. This project was officially unveiled by the then Chairman of Maldon District Council, Councillor Bob Boyce soon after the cameras went “live”. These cameras have already been used in several incidents but have also enabled the District Council to make more informed decisions during the Covid-19 crisis around social distancing and the High Street works. Officers have also been assisting Burnham Town Council in the design of a system to cover Burnham-on-Crouch High Street and the quay area.
- 3.3.5 Current concerns for the partnership hub focus around violence and vulnerability, and disruption of organised crime together with monitoring “hot spots” such as Maldon High Street, Promenade Park, Hythe Quay and some of the parks across the district where young people are congregating and consuming alcohol and using nitrous oxide canisters. Officers are currently reviewing the Public Space Protection Orders (PSPO) for the district with a view to extending the coverage to include the High Street, Hythe Quay and Promenade Park to include alcohol and drug misuse. The continued use of Operations Aegis, Overwatch and Sceptre are proving successful and

in recent weeks there have been significant arrests to disrupt both local and County Line drug networks. Another area which has been highlighted during the lockdown measures is the use of inland waterways: Hoe Mill Lock and Beeleigh Falls. There has been issues with anti-social behaviour, litter, drunkenness and dangerous parking. The South Essex Parking Partnership (SEPP) has increased patrols to tackle the parking issues in this area and a multi-agency meeting was held on 16 July 2020 to tackle the other problems which will result in effective signage being introduced together with days of action to follow as necessary.

- 3.3.6 The community safety function was subject to an internal audit by BDO in April 2020 with a final report being considered by Maldon District Councils Performance, Governance and Audit Committee on 30 July 2020. The audit received a “moderate” level of assurance for design and operational effectiveness. A copy of the final report was discussed by Responsible Authority Group (RAG) Members at the last meeting held on 8 September 2020 and it was agreed that the highlighted recommendations were complete, and this be reported to Overview and Scrutiny Committee on 22 October 2020 for sign off. 4. CONCLUSION

The shared working arrangements between Maldon and Chelmsford continue to support local priorities, high level policing priorities and the priorities of the current PFCC plan and has strengthened with the co-location of the community policing team in March 2019 and additional policing resources in town centres and rural areas. Maldon CSP remains efficient and responsive to emerging issues and more importantly positions itself strongly for future funding arrangements with the Essex Police, Fire and Crime Commissioner, statutory partners and local / national initiatives.
