Be responsive to emerging hotspots and develop suitable interventions to tackle community issues.	Multi-agency targeted response in identified areas: <ul style="list-style-type: none"> • Street racing and car cruising at Tesco and Morrisons (community meetings, provision of youth diversionary activities and enforcement) • Maldon Promenade (community meetings, provision of youth diversionary activities and enforcement – with a focus on gang activity) • Tackle acquisitive crime with an emphasis on vehicle crime, dwelling burglary and rural crime 	Ongoing	
Promote key media campaigns and national campaigns to raise the awareness of emerging threats and trends.	Increased awareness by effective use of social media and Essex Community Messaging around key areas of concern, which will include supporting Safer Essex initiatives.	Ongoing – diary of events	
Promotion of the Keep Safe scheme in Maldon and extension to Burnham.	Scheme for vulnerable people (including people with dementia and learning disabilities) where places of safety have been identified across the city for people can go if they need assistance. The aim is to encourage people to maintain an independent lifestyle where possible.	Ongoing – networking meetings held quarterly	
Promotion of the Hate Incident Reporting Centre and Ambassador network.	Provide an additional place for people to report a hate crime or incident as an alternative to going directly to the police.	Ongoing – networking meetings held quarterly

Increase awareness and enable people to make informed decisions to improve their perception of safety.	Ongoing	
Coordinate an annual public perception survey.	Enables the partnership to build up a picture of the fear of crime and identify what people's main concerns are. The results feed into the Strategic Assessment and will help to inform the priorities for the year ahead.	31 st March - annually	
Work with the South Essex Parking Partnership and Chelmsford City Council on the School Parking Initiative.	Established in response to ongoing complaints around parking issues at schools. The aim is to challenge parking behaviour, change perceptions, reduce anti-social behaviour and improve community cohesion.	Prototype school has been selected and work will start on the 23 rd February.
