APPOINTMENT OF REPRESENTATIVES ON LOCAL GOVERNMENT AND OUTSIDE BODIES

1. PURPOSE OF THE REPORT

1.1 To consider the appointment of representatives to serve on the Local Government and Outside Bodies for the ensuing Municipal Year.

2. RECOMMENDATIONS

- (i) that the changes to the Local Government and Outside Bodies as set out in paragraph 3.2 below, be noted; and
- (ii) that the Council agrees the appointment of representatives to Local Government and Outside Bodies, as detailed in **APPENDIX 1**, for the ensuing Municipal Year.

3. SUMMARY OF KEY ISSUES

- 3.1 A list of the proposed appointments to Local Government and Outside Bodies is attached as **APPENDIX 1**. These appointments are distinct from those made from within individual Committee memberships, which will be referred to Committees at their first meetings.
- 3.2 Attention is drawn to the following Outside Bodies and the changes that have become apparent over the past year. These changes have been reflected within the list attached at **APPENDIX 1**.
 - Essex County Council Transport Group (Maldon) Removed as the Group no longer meets. The Council will be represented on the Heart and Haven Transport Board.
 - **Essex Outward Bound Association** Removed as the Council has no direct involvement with the Essex Outward Bound Association. The Council now works closely with Active Essex.
 - Heart of Essex and Haven Gateway Local Enterprise Partnership Name changed to Haven Gateway Partnership.

- Maldon Citizens' Advice Bureau (CAB) This Group has been removed as
 Members are no longer appointed as Trustees with voting rights. The
 Council's liaison with the CAB will be via the Maldon Citizens Advice
 Bureau Liaison Committee and its Membership will be increased from two to
 three Members.
- **Maldon District Business Association** Removed as this Association no longer exists.
- Maldon District Rural Housing Task Group The Community Services Committee is recommending to the Council that this group be terminated (Minute No. 1136 refers). If the Council agrees this recommendation then this Group should be removed from the list of proposed appointments to Local Government and Outside Bodies (APPENDIX 1).
- Maldon Older People's Floating Service Steering Group The Council has been advised by One Support that this Group no longer meets, but the Strategic Housing Manager is seeking further clarification on this and requirements under the Groups Terms of Reference.
- Relate North Essex and East Herts (Family Services) Removed as Councillor R Pratt advises this body no longer meets.
- Sense of Place Board Added to Outside Bodies aligned with the Planning and Licensing Committee, as appointed by the Council.
- The Sparsity Partnership for Authorities Delivering Rural Services (SPARSE) The Council agreed on 7 April 2016 not to continue subscription to SPARSE. In accordance with its constitution, 12 months' notice of termination of membership is required.
