The Public Body Biodiversity Duty

1. Purpose of Report

This report is a statutory requirement on the Council as a public body and responds to the Council's new responsibilities under the Environment Act 2021 for protecting and enhancing biodiversity across the District.

The Environment Act 2021 amends the Natural Environment and Rural Communities Act 2006 (NERC Act) by introducing (section 40(1)) a proactive duty to "from time to time consider what action the authority can properly take, consistently with the proper exercise of its functions, to further the general biodiversity objective".

Public bodies which are also Local Planning Authorities, like Maldon District Council, must also consider what action it can take "to further the general biodiversity objective" through their planning functions. This includes the delivery and monitoring of Biodiversity Net Gain (BNG) which is now a mandatory requirement on most new development in the District.

This report sets out what the Council currently does to conserve and enhance biodiversity as part of its functions and sets out how the Council will meet the new challenges posed by the Environment Act 2021 in respect of biodiversity building on its existing policies, partnerships and actions setting out a clear strategy for going forward that will maximise the benefits for biodiversity within the resources and influence available to the Council.

2. What is included in the Biodiversity Report: First Consideration

The Biodiversity Report: First Consideration is a corporate responsibility that goes across all Council departments, their actions and decision making. Government guidance¹ specifically requires Local Authorities to publish biodiversity reports in future which contain:

- a summary of action which the Authority has taken over the period of the report looking back in time since its approval
- a summary of the Authority's plans for the five years following the report
- quantitative data and any other information the authority considers is appropriate is included in the report.

The Environmental Act 2021 and its associated guidance stipulates publication and frequency rules as follows:

- the first report must cover no longer than three years, subsequent reports must cover no longer than 5 years and run consecutively.
- an updated report must be published within 12 weeks of the last day of the report.

Government guidance for complying with the biodiversity duty summarises what public authorities must do to comply with their new legal duties. They must:

- consider what they can do to conserve and enhance biodiversity.
- agree policies and specific objectives based on their consideration.
- act to deliver their policies and achieve your objectives.

The report has three compulsory sections which are described in the Government guidance as follows:

Section 1: Your policies, objectives and actions

You must include this information in your report.

Explain:

- the policies and objectives you have set to meet your biodiversity duty;
- the actions you've completed, either alone or in partnership with others, that benefit biodiversity.

Section 2: How you have considered other strategies

You must include this information in your report.

Explain how you've taken into account:

- Local Nature Recovery Strategies
- protected site strategies
- species conservation strategies

For example, include information about how:

- you've advised or worked in a Local Nature Recovery Strategy (LNRS) partnership in your area
- these strategies influenced your policies, objectives or actions

Section 3: Your future actions

You must include this information in your report.

• Explain how your organisation plans to fulfil your biodiversity duty over the 5 years following the end of this reporting period.

You can report your plans for future actions in each section of your report alongside the ones you've achieved.

In addition, the guidance also refers to the optional content that could be included such as top achievements, how policies and actions have helped, highlights and challenges. This will be reviewed and included in the Second Consideration published by 1 January 2026.

The Maldon District Biodiversity Report First Consideration uses this format and sets out how it will:

- review what the Council already does for biodiversity.
- work corporately as an organisation to develop policies and actions that will improve outcomes for biodiversity.
- monitor progress and effectiveness on agreed policies and actions.

Whilst the Biodiversity Report must be reviewed within three years and subsequent reports every five years there was a requirement for the first report to set out the Council's "First Consideration" of what action to take for biodiversity in the Maldon District to be published by 01 January 2024 and for policies and objectives to be agreed as soon as possible after this. To ensure compliance, a draft of this report was published on the Council's website awaiting further work and approval by the Performance, Governance and Audit Committee.

The following governance and timetable map will be followed for the review and approval of future considerations of the Maldon District Biodiversity Report noting the requirement that the end date of the first reporting period should be no later than 01 January 2026 and thereafter every five years.

Section 1 – Our Policies & Actions

The Council's Corporate Plan 2023-2027 provides the strategic framework for all the Council's responsibilities and functions. The priorities most relevant to biodiversity are:

- Enhancing & Connecting Our Place
- A Greener Future

The Council's Climate Action Plan 2021-2030 sets several climate action pledges which include "Show Nature We Care".

As a Local Planning Authority, the Council already has a series of strategic and local planning policies in the approved Maldon District Local Development Plan (LDP)² which set requirements for how biodiversity, habitats and ecological management should take place in the District. These are:

- D2 Climate Change and environmental Impact of New Development
- N1 Green Infrastructure Network

In addition, the Neighbourhood Plans prepared by Town and Parish Councils and made by the Local Planning Authority all have a strong environmental focus and contain neighbourhood level planning policies that protect and encourage improvements to nature and wildlife within the plan areas of:

The Government has already legislated that that 10% BNG is mandatory for all major development consented after early 2024. This bolsters the LDP Policy N2 (Natural Environment, Geodiversity and Biodiversity) which requires that all development should seek to deliver net biodiversity gain where possible. The LDP Plan Review will carry forward the national requirement for 10% BNG and elaborate on how that can be met locally.

The Council has for many years, through successive Local Plans, identified and designated a range of Local Wildlife Sites (LoWS) to be protected for their wildlife interest and seeks to ensure their continued protection and enhancement through policies and actions. The Council has positively worked with the Essex Local Nature Recovery Partnership between 2022 and 2023 to have these formally ratified.

3. Ongoing Monitoring

As part of the actions noted above, the Council will consider how both existing and any new actions will be monitored to enable reporting in the Maldon District Biodiversity Report Second Consideration in 2026.

BNG as already part of the planning system and has its own monitoring requirements set out in legislation and guidance which the Council will follow. In addition, the Council publishes an Annual Monitoring Report (AMR) for the Local Plan policies and a Climate Action Plan report for delivery against the Maldon District Climate Action Plan. The relevant content and monitoring of these reports will form part of future Biodiversity Reports.

Most partnerships that form part of the Council's commitment to biodiversity already have reporting requirements which can be captured for future Biodiversity Reports to track the delivery of multiagency work.

In devising monitoring proposals, the Council will be mindful of the resources available and will seek to avoid duplicating work done elsewhere so that where monitoring is already being done this will be incorporated into an output for the Biodiversity Report.
