Members concern is noted that this percentage appears artificially high in comparison to personal experience; there are a number of factors that indicate that this is an accurate representation: Whilst Maldon District does have a comparatively high food waste recycling rate, approximately 60% of our residents do not participate in the

			Whilst we appreciate concerns raised by some residents about the colour and wording of the sticker, the campaign is proving to be highly effective at encouraging behaviour change. Other districts which implemented the scheme before Maldon have seen improved food waste collection rates (of approximately 24%). Additionally, our service has seen an increased demand for food waste caddies as a result of the scheme.
