

NEW CODE OF CONDUCT - REGISTER OF MEMBERS' INTERESTS

GENERAL NOTICE OF REGISTERABLE INTERESTS

I, Councillor Michael Alexander Porter of Tolleshunt Knights Parish Council set out below under the appropriate headings my interests, which I am required to declare under the Localism Act 2011 and the Council's Code of Conduct. Where I have no such interests I have stated "NONE".

Disclosable pecuniary interests
