

NEW CODE OF CONDUCT - REGISTER OF MEMBERS' INTERESTS

GENERAL NOTICE OF REGISTERABLE INTERESTS

I, Councillor Mr Andrew John Snowdon of Asheldham and Dengie Parish Council set out below under the appropriate headings my interests, which I am required to declare under the Localism Act 2011 and the Council's Code of Conduct. Where I have no such interests I have stated "NONE".
